

**ARTICLES OF ORGANIZATION
OF
SPIRA, BOYD, BEADLE & McGARRELL, LLC.**

The undersigned hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608 of the Florida Statutes.

ARTICLE I – NAME

The name of this limited liability company shall be SPIRA, BOYD , BEADLE & McGARRELL, LLC. (the "Company").

ARTICLE II – DURATION

The Company shall commence upon the execution of these Articles and shall exist perpetually.

ARTICLE IX – ADOPTION OF REGULATIONS



ARTICLE X – AMENDMENT


The Company shall have the power to amend or supplement these Articles of Organization when approved by unanimous vote of the Members.




