The duration of the limited liability company shall be perpetual, save and until its dissolution in accord with the Florida Limited Liability Company Act and the operating agreement of the limited liability company.

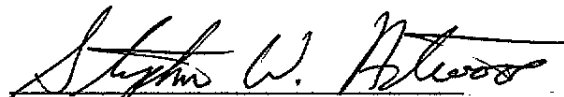
**ARTICLE VII**

**ARTICLE VIII**

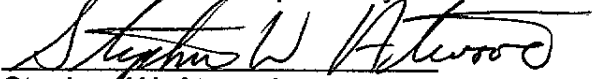
The limited liability company has been formed to conduct any lawfully activities permitted under Florida law in the State of Florida.

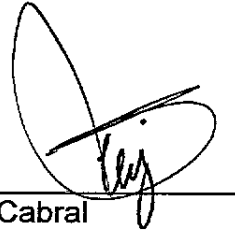
