ARTICLES OF ORGANIZATION OF BUSBEE THOMPSON, L.C.

ARTICLE I - NAME

The name of this Limited Liability Company is BUSBEE THOMPSON, L.C.

ARTICLE II - ADDRESS AND PRINCIPAL PLACE OF BUSINESS

- 5.
