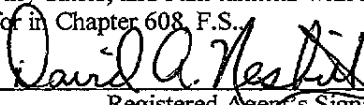

The Limited Liability Company is to be managed by one manager or more managers and is, therefore, a manager – managed company.

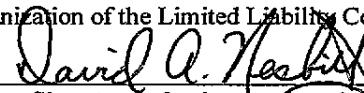
## **ARTICLE V – Purpose of Company:**

The Limited Liability Company is formed for the following purposes:

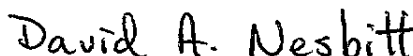
- To acquire by purchase or lease property of all kinds (real, personal and intangible) and other rights and interests therein;
