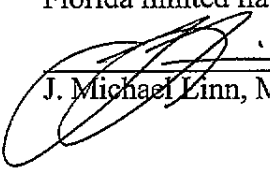
## ARTICLE 6

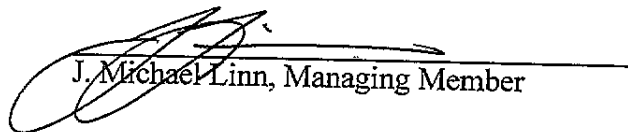
