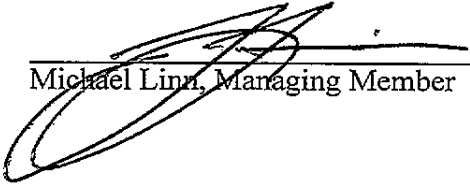
1. The date of filing of the articles of organization was February 15, 2001.
