**ARTICLES OF ORGANIZATION
OF
LLADNEK INDUSTRIES, LLC**

The undersigned hereby certifies that the members named herein have associated together for the purpose of becoming a Limited Liability Company under Florida Statutes Chapters 608, providing for profit and the following Articles of Organization are hereby adopted:

**ARTICLE I
NAME**

The name of the Limited Liability Company shall be LLADNEK INDUSTRIES, LLC

**ARTICLE II
DURATION, EFFECTIVE DATE**

This Limited Liability Company shall commence upon the acceptance of the Articles of Organization by the Secretary of State of Florida and shall continue in existence until the expiration of fifty (50) years from such commencement date, unless sooner terminated, liquidated, or dissolved by law or by the unanimous consent of the Members.

- C. To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the above described purposes, either alone or in association with others, including matters incidental or pertaining to, or connected with such purposes, provided the same shall not be inconsistent with the laws of the State of Florida.

ARTICLE VI
RESTRICTIONS ON MEMBERSHIP
RIGHT TO ADMIT ADDITIONAL MEMBERS

Existing members shall have the right to admit new members by consent of members representing eighty (80%) of the ownership interests in the Limited Liability Company. Contributions required of new members shall be determined as of the time of admission to the Limited Liability Company in accordance with the Regulations.

A member's interest in the Limited Liability Company may not be sold or otherwise transferred without written consent of members representing eighty percent (80%) of the ownership interests in the Limited Liability Company and otherwise in accordance with the Regulations of this Limited Liability Company.

ARTICLE VII
CONTINUATION

Upon death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the membership of a member in the Limited Liability Company, the remaining members shall have the right to continue in the business upon unanimous consent of such remaining members.


ARTICLE X


