**ARTICLES OF ORGANIZATION
OF

The mailing address and street address of the Company is 532 Ponte Vedra Boulevard, Ponte Vedra Beach, Florida 32082.

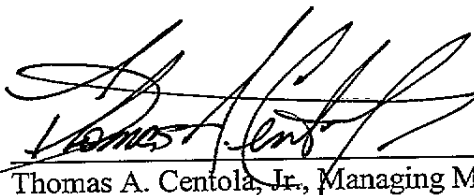
ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

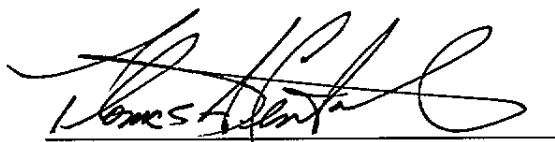
