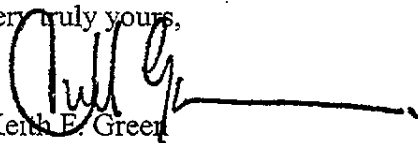

1. Name. The name of the limited liability company is Kudu Ventures, L.L.C.

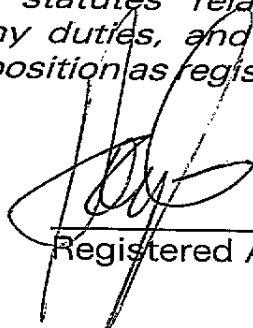
2. Duration. The period of duration of the limited liability company is perpetual.

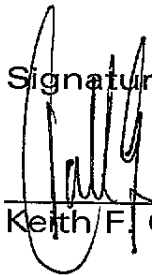

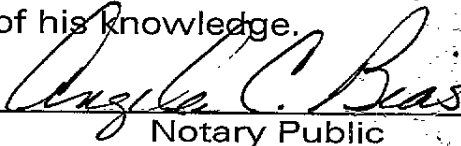

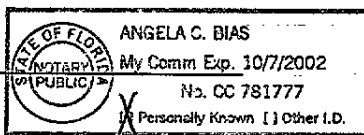
