ARTICLE I
NAME

The name of this Limited Liability Company is SUNCOAST METAL RECYCLING, L.L.C. (the "Company").

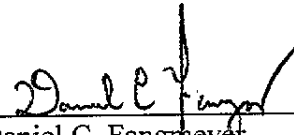
