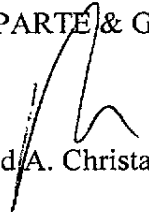

OF

The undersigned, being authorized to execute and file these Amended and Restated Articles of Organization (original Articles of Organization filed on February 16, 2001) pursuant to Chapter 608, Florida Statutes, hereby certifies that:

**ARTICLE I—Name**

The name of the Limited Liability Company is "The Hargrett LLC."

**ARTICLE II—Address**

The mailing address and street address of the principal office of the Limited Liability Company is 2002 East Emma Street, Tampa, Florida 33610.

**ARTICLE III—Registered Agent**

**ARTICLE VI—Purpose and Powers**

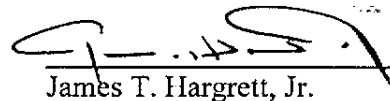

**Section 2.** The Limited Liability Company may exercise all powers, rights, and privileges conferred on limited liability companies pursuant to the laws of the State of Florida.

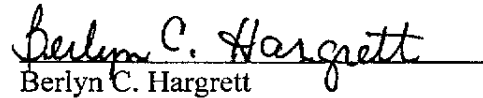

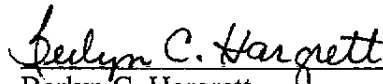
