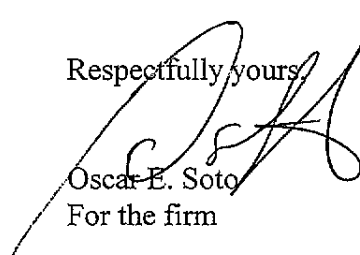

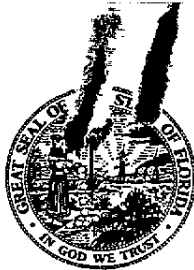

The undersigned, for the purpose of forming a Limited Liability Company, under the Florida Limited Liability Company, Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I-NAME**

The name of the Limited Liability Company shall be LUMIAR ENTERPRISES, L.L.C. ("Company"). The principal office and place of business of the company in Florida shall be 7321 S.W. 6<sup>th</sup> Court, Plantation, Florida 33317. **ARTICLE II-DURATION**

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these Articles of Organization.

members of the company other than the member proposing to dispose of his or her interest approve the proposed transfer by unanimous written consent.

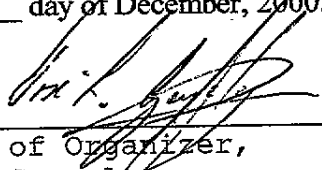
## ARTICLE VI-TERMINATION OF EXISTENCE

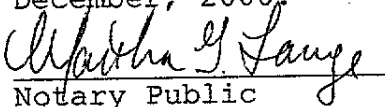

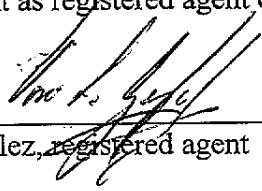
