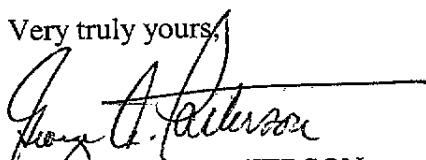

**ARTICLES OF ORGANIZATION
OF

ARTICLE I — Name:

The name of the Limited Liability Company (hereinafter referred to as the "Company") is

A. The Limited Liability Company is to be managed by the members and the name and address of the present managing member is:

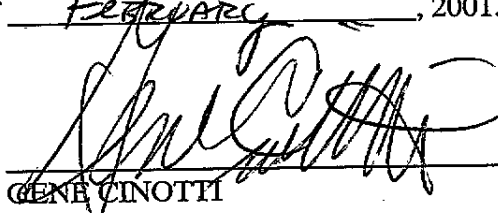

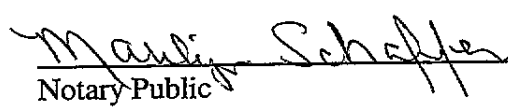
