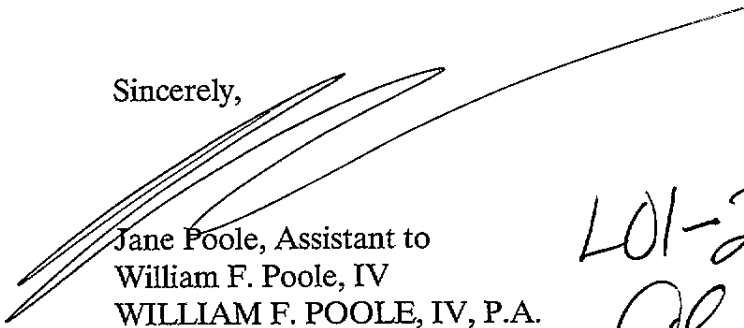

Effective Date**

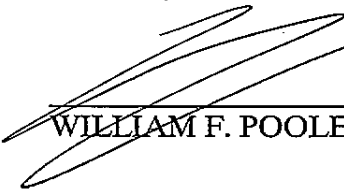
These Articles of Organization shall be effective and the limited liability company's existence shall begin as of the date of filing of these Articles of Organization.
