OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Article of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be "ISLAND TRUST, LLC"

ARTICLE II - DURATION

The limited liability company shall exist from the date of the filing of these Articles of Organization with the Department of State until the limited liability company is dissolved in accordance with its Operating Agreement.

ARTICLE III - PRINCIPAL OFFICE

ARTICLE V – CAPITAL CONTRIBUTIONS AND OWNERSHIP UNITS

The members of the limited liability company shall contribute to the capital of the limited liability company the cash set forth in Exhibit "A" and each member shall receive the number of ownership units as set forth in said Exhibit. A member may transfer his or her interest in the limited liability company as set forth in the Regulations of the limited liability company.

ARTICLE VIII – CONTINUATION OF BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or on the occurrence of an event which terminates the continued membership of a member in the limited liability company, the business of the limited liability company shall terminate and the limited liability company shall be dissolved, unless a majority of the remaining members of the company agree to continue the business of the company..

ARTICLE IX – MANAGEMENT

The limited liability company shall be managed by its members in accordance with regulations adopted by the members for the management of the business and affairs of the limited liability company. These regulations may contain any provisions for the regulation and management of the affairs of the limited liability company not inconsistent with law or


