**ARTICLES OF AMENDMENT TO
THE ARTICLES OF ORGANIZATION OF
NEXGEN, LLC**

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned Florida limited liability company hereby adopts the following Articles of Amendment to its Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company is Nexgen, LLC (hereinafter referred to as the "Company").

ARTICLE II - DATE OF FILING

The Company's Articles of Organization were filed on February 22, 2001.
