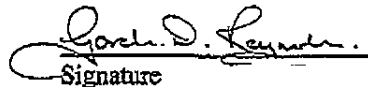

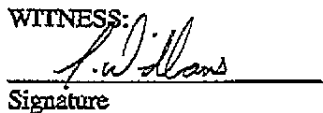
LIMITED POWER OF ATTORNEY
