**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I**  
**NAME**

The name of this Limited Liability Company shall be TJ & J TRUCKING, L.L.C. (hereinafter "Company").

**ARTICLE II**  
**ADDRESS**

The mailing address and street address of the principal office of the Company is 6831 Firebird Drive, Orlando, Florida, 32810.

**ARTICLE III**  
**DURATION**

The Company shall commence its existence on the date these Articles Of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is dissolved earlier as provided in these Articles Of Organization or in the regulations.

**ARTICLE IV**  
**REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the Company in the state of Florida are TROY D. SMITH, 6831 Firebird Drive, Orlando, Florida, 32810. The Company may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Organization.

ARTICLE V  
ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on the terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless 100% of the members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE VI  
MEMBERS' RIGHT TO CONTINUE BUSINESS

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by unanimous vote of the remaining members.

ARTICLE VII  
MANAGEMENT

The Company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. INDEMNIFICATION

In addition to any rights and duties under applicable law, the Company shall indemnify and hold harmless all of its present and former members, employees and agents from and against all liabilities and obligations, including attorneys' fees, incurred in connection with any actions taken or failed to be taken by said members, officers, employees and agents in their capacity as such except for willful misconduct or gross negligence.

ARTICLE X  
LIMITED LIABILITY OF MEMBERS

The private property of the members shall not be subject to payment of the Company's

debts to any extent.

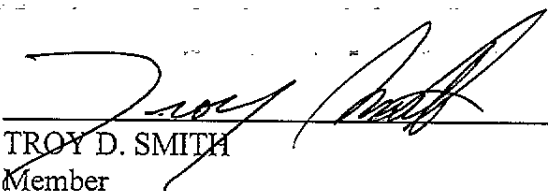
ARTICLE XI
