The name of the limited liability company is: The Cameron Group, LLC

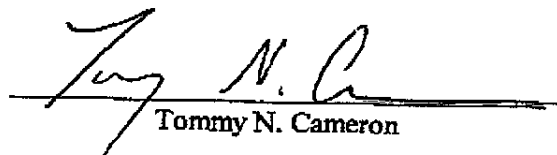

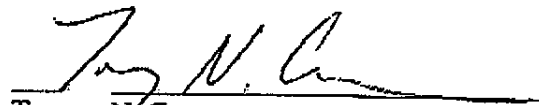
