Gentlemen:

Please use this letter as my request to receive the Uniform Business Report (UBR) for the above accounts for calendar years 2001 and 2002. (I assume that would be the 2002 and 2003 forms.) I honestly did not know there was such a filing until about a week ago while doing some research. Because of my unfortunate quick move, (see story below) these forms never reached me, however, I am now in the process of correcting this omission. It would be appreciated if you could send them to my address listed above.

I set up these 2 entities in early 2001 with the full intention of becoming a Florida resident the following year. However, after I had set these wheels in motion, my 80-year-old mother had a series of strokes beginning in November of 2001 and ending in September 2002. When these strokes occurred, I had to quickly cancel my strategy of moving to Florida and dropped everything to return full-time to Ohio to take care of her, as I have been her primary caregiver since my father passed away in 1990. She spent a lot of time during that above timeframe going in and out of the hospital and subsequent nursing facilities. In October 2002, she began physical therapy and is now to the point where she has become independent again. Hopefully, with the new medicine she is taking, she will have many more years ahead of her.

Unfortunately for me, during this time, I lost my focus on my plans and concentrated on my mother. As her health stabilized, I began to assess the damage I had done to my life by switching directions so quickly. From a business side, I lost a large amount of money in 2001 when I lost my focus and quickly moved back to Ohio. Furthermore, because of my move, I never received any tax returns, and quite honestly, because of my full-time commitment to my mother, I just never really thought about my various tax filings.

Finally, in February of 2003, I felt like the weight was lifting from me and I began to move forward on taking care of my problems. I then realized I hadn't filed any Florida tax returns and I began to immediately gather my information I needed to become current. Thankfully for me, I found out there was an office of the Florida Dept. of Revenue only 4 miles from my house in Ohio and I proceeded to tell them my needs and they kindly provided me with the necessary forms. (However, they were unaware of any UBR form and I now know why: it's not a Dept. of Revenue form.) I have concurrently mailed all of my tardy tax filings to proper agencies as of this date.

Hopefully, I am hoping that by sending you the above explanation for my tardiness in filing (hence, this letter) then perhaps you would also be able to give me forbearance on any penalty for the UBRs.

To that regard, I would be eternally grateful if you could help me concerning that matter so that I may return to my original course of action and get my business plans going again in the State of Florida without any burden of penalties or interest for this period of time.
