**ARTICLES OF ORGANIZATION
OF
FOWLER GAMES TRUCKING, LLC
A Florida Limited Liability Company**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

ARTICLE 1 – Name: Fowler Games Trucking, LLC (the “Company”).

ARTICLE 2 – Address: The mailing address and street address of the principal office of the Company is: 4310 Sheridan Street, Suite 202, Hollywood, Florida 33021

ARTICLE 3 – Registered Agent: The name of the initial registered agent of the Company is: Joseph Fowler. The initial street address of the registered office is 4310 Sheridan Street, Suite 202, Hollywood, Florida 33021.

ARTICLE 4 – Management: The limited liability company is to be managed by one manager or more managers and is, therefore, a manager-managed company. The initial manager of the Company is Joseph Fowler.

ARTICLE 5 – Period of Duration: The period of duration of the Company shall be perpetual.


