These Articles of Organization of Dynamic Composites, LLC, a Florida limited liability company (the "Company"), dated as of the 27th day of February, 2001, are being duly executed and filed by Harold W. Mullis, Jr., the organizer, authorized to form a limited liability company under the Florida Limited Liability Company Act (Chapter 608, Florida Statutes) (the "Florida Act").

- FIRST:** The name of the limited liability company is Dynamic Composites, LLC
- SECOND:** The nature of the business to be transacted and the purposes to be promoted or carried out by the Company is to engage in any lawful act or activity for which limited liability companies may be formed under the Florida Act, and by such statement all lawful acts and activities shall be within the purposes of the Company's business as permitted under the Florida Act.

- SIXTH:** The Members of the Company may admit additional Members upon the requisite consent of the Members, in accordance with the Dynamic Composites, LLC Limited Liability Company Regulations (the "Regulations").
- SEVENTH:** The remaining Members, if any, pursuant to the terms of the Regulations or applicable law, may elect to continue the Company's business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member.

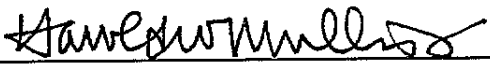
