ARTICLE I - Name

The name of the limited liability company is EOLA SOUTH , L.L.C.

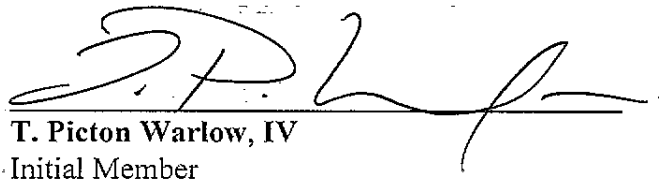
ARTICLE V - Admission of Additional Members
