## ARTICLES OF ORGANIZATION OF GULF SOUTH DEVELOPERS, LLC

.

The undersigned as Organizer of a limited liability company pursuant to the Florida Limited Liability Company Act adopts the following Articles of Organization.

- 1. <u>Name</u>. The name of the limited liability company is Gulf South Developers, LLC.
- 2. <u>Duration</u>. Its period of duration is perpetual from the date of execution, unless (a) extended by the Members, (b) sooner dissolved by the Members, or (c) dissolved upon a statutory event of dissolution.
