ARTICLES OF ORGANIZATION
of
METRO WEST CAFÉ & CATERING, LLC

a Florida Limited Liability Company

ARTICLE I – Name:

The name of this limited liability company is Metro West Café & Catering, LLC

ARTICLE II – Period of Duration:

The limited liability company's period of duration shall be perpetual, commencing March 2, 2001.

ARTICLE III – Registered Agent:

The initial registered office of the Limited Liability Company shall be 5728 Major Blvd., Suite 550, Orlando, Florida 32819, and the name of the initial registered agent of the Limited Liability Company shall be David S. Cohen, Esquire.

ARTICLE IV – Principle & Mailing Address:

The principal and mailing address of the Limited Liability Company shall be 3300 S. Hiawassee Road, Suite 103, Orlando, Florida 32853.

ARTICLE V – Admission of Additional Member(s):

The Member(s) may admit new Member(s) in accordance with the Operating Agreement for the company.

ARTICLE VI – Member(s) Rights to Continue Business:

The right, if given, of the remaining member(s) of the limited liability company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall be by unanimous written consent of all remaining member(s) or under a right to continue stated in the Operating Agreement of the company.

ARTICLE VII – Limitation on Agency Authority of Members:

No member of the Company shall be an agent of the Company solely by virtue of being a member, and member shall have authority to incur debt or contract liability on behalf of the company solely by virtue of being a member.


ARTICLE VIII - Business Purpose and Powers:

Unless otherwise stated in the Operating Agreement for the company, the management of the limited liability company's business and affairs shall be vested in the member(s).


