ARTICLES OF ORGANIZATION
OF

ARTICLE I.

PREAMBLE; FORMATION

The undersigned, DON SAYER and CONNIE SAYER, do hereby form a Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, titled as the "Florida Limited Liability Company Act," as hereinafter set forth.

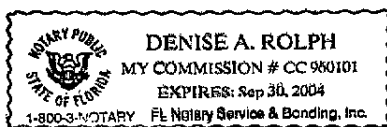



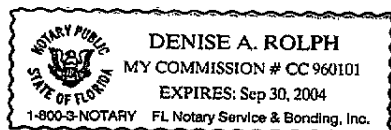
