ARTICLES OF ORGANIZATION

OF

1ST STREET 8 UNIT CONDO, L.L.C.

a Florida Limited Liability Company

**ARTICLE I
NAME**

The name of this Limited Liability Company is 1ST STREET 8 UNIT CONDO, L.L.C. (the "Company").

**ARTICLE II
PURPOSE**

A. Purposes. The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Chapter 608, Fla. Stat., as the same may be amended from time to time.


ARTICLE XI

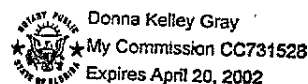
