
1. The date of filing of the Articles of Organization was March 8, 2001.

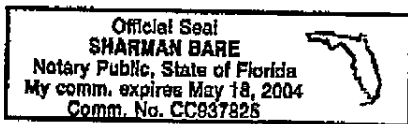
