Article III - Duration



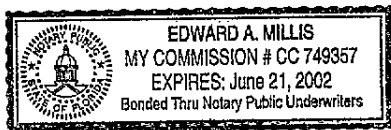
