**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be:

CARDS & GIFTS OF ST. CLOUD, LLC

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the company is 4047 13th Street, St. Cloud, Florida 34769.

ARTICLE III – DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or another effective date as specified. The company's existence shall be perpetual.

ARTICLE IV – REGISTERED OFFICE AND AGENT

ARTICLE V – ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make initial and additional capital contributions to the company as provided in the regulations.

ARTICLE VI – MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by a majority vote of all the remaining members.

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with the law or these articles of organization. 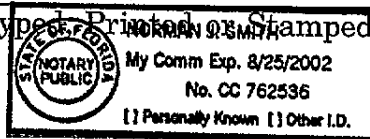
