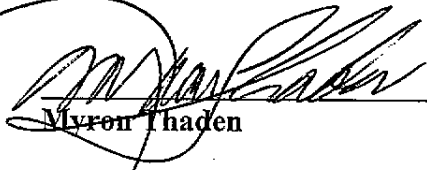
**ARTICLE VI

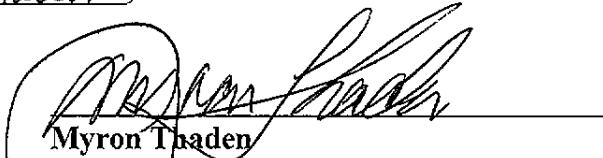
CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE
