

MANAGEMENT; APPARENT AUTHORITY



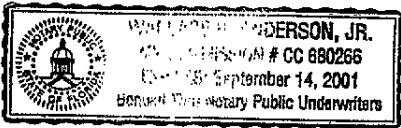
