**ARTICLES OF ORGANIZATION**  
of  
**AYAD COMPANY, L.L.C.**

The undersigned hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit and hereby adopt the following Articles of Organization for such limited liability company:

**ARTICLE I**  
**NAME AND PRINCIPAL OFFICE**

The name of this limited liability company is AYAD COMPANY, L.L.C., and its principal office and mailing address is located at 840 South Grand Highway, Clermont, FL 34711.

**ARTICLE II**  
**DURATION**

The existence of this limited liability company shall be perpetual, commencing upon the filing of the Articles of Organization by the Florida Department of State.

**ARTICLE III**  
**PURPOSE**

The purpose of this limited liability company is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV**

The initial managers, who shall serve until the earlier of their death, resignation, replacement or until the first annual meeting of members and their successors are elected and qualified, shall be:




