**ARTICLES OF ORGANIZATION  
OF  
MICHAEL C. MORRIS, M.D., LLC.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be MICHAEL C. MORRIS, M.D., LLC. ("company").

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company is 2117 Ocean Drive, New Smyrna Beach, Florida 32169.

**ARTICLE III -- DURATION**

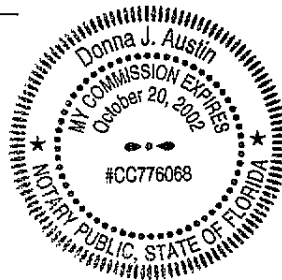


**CERTIFICATE OF DESIGNATION OF REGISTERED
