PLAN OF MERGER

THIS PLAN OF MERGER of SOUTH SARASOTA HIDE-AWAY, a Florida joint venture, and SOUTH SARASOTA HIDE-AWAY, L.C., a Florida limited liability company, pursuant to Section 608.438 of the Florida Statutes, is adopted as follows:

- A. SOUTH SARASOTA HIDE-AWAY, a Florida joint venture, shall be merged with and into SOUTH SARASOTA HIDE-AWAY, L.C., a Florida limited liability company, to exist and be governed by the laws of the State of Florida.
- B. The name of the surviving limited liability or business entity shall be SOUTH SARASOTA HIDE-AWAY, L.C., a Florida limited liability company.
- C.
