ARTICLES OF ORGANIZATION OF CORAL INVESTMENTS,

SECOND: CORAL INVESTMENTS, LLC, shall have a perpetual duration from the date of filing of these Articles of Organization.

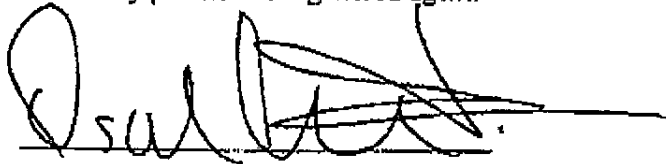
