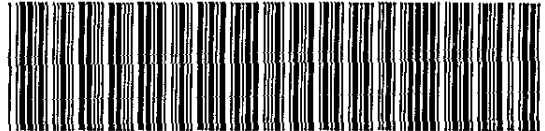

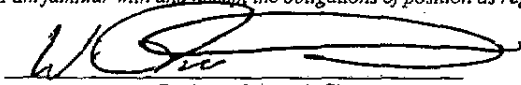
RESTATED AND AMENDED ARTICLES OF ORGANIZATION  
OF

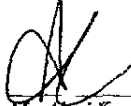
Sixth: The duration of the Limited Liability Company shall be perpetual.

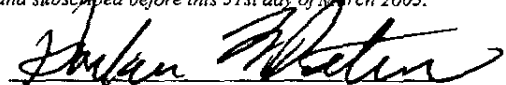
