#### ARTICLES OF ORGANIZATION

OF

## SEVILLA, LLC, a Florida limited liability company

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

### ARTICLE I: NAME

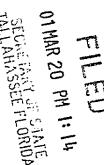
## ARTICLE X: REGULATIONS
