**ARTICLES OF ORGANIZATION OF
OAKMONT LAND DEVELOPMENT, L.L.C.**

ARTICLE I. NAME

The name of the Limited Liability Company ("Company") is
OAKMONT LAND DEVELOPMENT, L.L.C.

ARTICLE II. PURPOSE

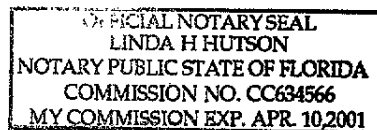
