ARTICLES OF ORGANIZATION
OF

The undersigned, as the initial members of the below-identified limited liability company, and for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be Forest Environment Specialists, LC ("the Company").

ARTICLE II -- ADDRESS

ARTICLE III -- DURATION
