ARTICLE IV - Purpose

The sole purpose for which the Company is organized is to purchase, own and operate the real property known as "Hillsboro Shoppes" at 28-81 South Federal Highway, Deerfield Beach, Florida, (The "Real Property").

ARTICLE V - Limitations

- A. The Company shall only be permitted to incur the indebtedness that encumbers the real property and liabilities in the ordinary course of business relating to the ownership and operation of the real property for so long as the conduit Real Estate Mortgage Investment Trust loan encumbering the real property to the favor of Lehman Brokers Commercial Mortgage Trust (The "Mortgage") is still outstanding.
- B. The Company is prohibited from engaging in any dissolution, liquidation, consolidation, merger or asset sale so long as the mortgage is still outstanding.
- C. The Company is prohibited from amending its Articles of Organization as long as the mortgage is still outstanding.
- D. The unanimous consent of all members and the Company manager shall be required to permit the Company to; (i) file, or consent to the filing of, a bankruptcy or insolvency petition or otherwise institute insolvency proceedings; (ii) to dissolve, liquidate, consolidate, merge, or sell all or substantially all of the assets of the Company; and (iii)engage in any other

E. business activity other than the ownership and operation of the real property. The manager of the Company shall be required to consider the interests of the Company's creditors in connection with all Company actions.

In addition, the Company agrees that so long as the mortgage is still outstanding that it shall be permitted to have only one member and that member shall be Schoh Partners, a Florida General Partnership.
