ARTICLES OF ORGANIZATION

The undersigned, an authorized representative of a Member, desiring to form a limited liability company under and pursuant to Florida Statute 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

ARTICLE I - NAME

person is or was a manager or member of this company ("Indemnitee"), shall be indemnified and held harmless by this company to the fullest extent permitted by applicable law, as the same exists or may hereafter be amended. In addition to the indemnification conferred in this Article, the Indemnitee shall also be entitled to have paid directly by this company the expenses reasonably incurred in defending any such proceeding against such Indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same exists or may hereafter be amended. The rights and authority conferred by this Article shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, provision of the Articles of Organization or Operating Agreement of this company, agreement, vote of members or otherwise. Any repeal or amendment of this Article by the members of this company shall not adversely affect any right or protection of a manager or member existing at the time of such repeal or amendment.

The power to adopt, alter, amend or repeal the Operating Agreement of this company shall be vested in the members.


ARTICLE XIII - INFORMAL ACTION OF MEMBERS
