## ARTICLES OF ORGANIZATION

OF

## HENNIG CONSULTING, LLC

## a Florida limited liability company

- 1. The name of this limited liability company is **HENNIG CONSULTING**, **LLC** (the "Company").
- The Company is being formed for the following purposes:

Said indemnification shall include, but not be limited to, the expenses, including the cost of any judgments, fines, sentements and counsel's fees, actually and necessarily paid or incurred in connection with any action, suit or proceedings, whether civil, criminal, administrative or investigative, and any appeals thereof, to which any such person or his legal representative may be made a party or may be threatened to be made a party, by reason of his being or having been a manager, officer, employee or agent as herein provided.
