ARTICLES OF ORGANIZATION

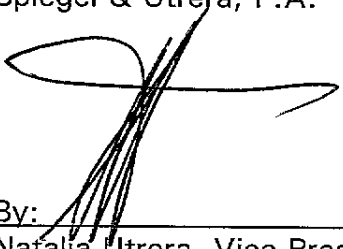
