ARTICLES OF ORGANIZATION

OF

HULDAFOLK, L.C.

The undersigned organizer, who is the authorized representative of the members of IIULDAFOLK, I..C. (the "Company") under the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization.

ARTICLE I - NAME

The name of the Company is HULDAFOLK, L.C.

ARTICLE II - DURATION

The period of duration of the Company shall be until December 31, 2026, unless terminated earlier pursuant to the Company's Regulations.

ARTICLE III - PRINCIPAL OFFICE

The principal place of business and mailing address of the Company is 4711 Yachtsmans Drive, Fernandina Beach, Florida 32034.

<u> ARTICLE IV - INITIAL REGISTERED AGENT AND ADDRESS</u>

The name and street address of the initial registered agent are Dennis L. Blackburn, Suite 200, Southpoint Building, 6620 Southpoint Drive, South, Jacksonville, Florida 32216.

<u> ARTICLE V - INITIAL MEMBERS</u>

The initial members of the Company shall be Andrew Simonsen, Trustee of the Andrew Simonsen Living Trust dated February 25, 1998, as amended; and Della Simonsen, Trustee of the Della Simonsen Living Trust dated February 25, 1998, as amended.

ARTICLE VI - ADDITIONAL MEMBERS

The members shall be entitled to admit additional members upon the consent of the Company's Managing Members. Following the consent of the Managing Members, any prospective member shall become a member upon payment of his, her or its contribution to the capital of the Company and upon such prospective member's agreement to comply with the Articles of Organization and Regulations of the Company.

ARTICLE VII - DISSOLUTION OF COMPANY

The death, retirement, resignation, expulsion, bankruptcy or dissolution of a member shall terminate the membership of that member in the Company. Upon the occurrence of any such event or any other that terminates the continued membership of a member in the Company, the Company shall be dissolved unless all of the remaining members consent to continue the existence of the Company.

ARTICLE VIII - MANAGING MEMBERS

The management of the Company shall be vested in the managing members. The names and addresses of the initial managing members are Andrew Simonsen, Trustee of the Andrew Simonsen Living Trust dated February 25, 1998, as amended; and Della Simonsen, Trustee of the Della Simonsen Living Trust dated February 25, 1998, as amended, both of 4711 Yachtsmans Drive, Fernandina Beach, Florida 32034, who shall serve as the Managing Members of the Company until their successors are elected and qualified.

<u>ARTICLE IX - RETURN OF CAPITAL</u>

No member shall have the right to the return of its contribution to capital except as provided in the Company's Regulations.

ARTICLE X - AMENDMENT OF ARTICLES OF ORGANIZATION

These Articles of Organization may be amended by majority vote of the Members of the Company as provided in Chapter 608, Florida Statutes.

<u> ARTICLE XI - REGULATIONS</u>

Regulations of this Company shall be approved and adopted by majority vote of the voting members of the Company and may be amended by a majority vote of the voting members of the Company.
