ARTICLES OF ORGANIZATION
OF
GUILLOT APOTHECARY, LLC

The undersigned authorized representative, being a natural person, eighteen (18) years of age or older, in order to form a limited liability company under Section 608.407 of the Florida Statutes, adopts the following Articles of Organization:

1. Name. The name of this limited liability company is GUILLOT APOTHECARY, LLC (the "Company").
