3. **ARTICLE 7: MEMBERS**, shall be amended as follows:

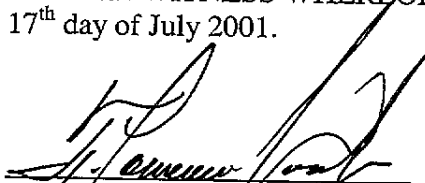
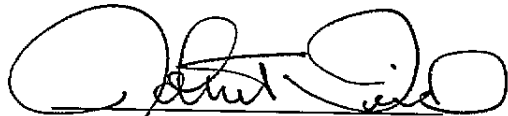
