**ARTICLES OF ORGANIZATION  
OF  
DOSTER & CARPENTER, L.L.C.**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

1. **Name.** The name of this limited liability company is DOSTER & CARPENTER, L.L.C.
2. **Duration.** The Company shall exist from the date of filing these Articles with the Department of State until the earlier of 25 years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.
3. **Mailing Address and Street Address.** The Company's mailing address is 130 Hillcrest Street, Orlando, Florida 32801. The Company's street address is 130 Hillcrest Street, Orlando, Florida 32801.
4. **Registered Agent and Office.** The name of the initial registered agent of the Company is Darrell F. Carpenter. The street address of the initial registered agent of the Company is 130 Hillcrest Street, Orlando, Florida.
5. **Additional members.** Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.
6. **Termination of Membership.** If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.
7. **Management of the Company.** The management of the limited liability company is reserved to the members. The following persons will initially be managing members:


