**ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY
COMPANY**

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is: Geodatex, LLC (the "Company").

**ARTICLE II
PERIOD OF DURATION**

The existence of the Company began March 19, 2001, and will continue until March 19, 2099, unless it is terminated earlier in accordance with the provisions of the Company's Operating Agreement.



The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to the Act.



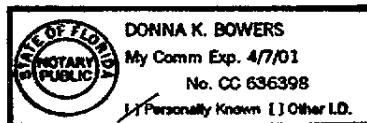
