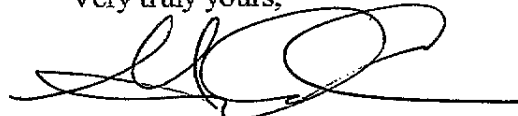

ARTICLE I
Name

The name of the limited liability company (Company) is N15144, L.L.C.

Admission of New Members

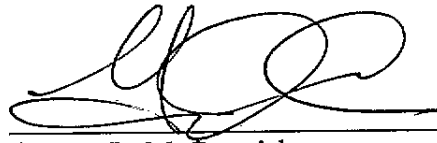
